# Conformational landscapes of DNA polymerase I and mutator derivatives establish fidelity checkpoints for nucleotide insertion

The fidelity of DNA polymerases depends on conformational changes that promote the rejection of incorrect nucleotides before phosphoryl transfer. Here, we combine single-molecule FRET with the use of DNA polymerase I and various fidelity mutants to highlight mechanisms by which active-site side chains influence the conformational transitions and free-energy landscape that underlie fidelity decisions in DNA synthesis. Ternary complexes of high fidelity derivatives with complementary dNTPs adopt mainly a fully closed conformation, whereas a conformation with a FRET value between those of open and closed is sparsely populated. This intermediate-FRET state, which we attribute to a partially closed conformation, is also predominant in ternary complexes with incorrect nucleotides and, strikingly, in most ternary complexes of low-fidelity derivatives correlates well with reduced affinity for complementary dNTPs and highlights the partially closed conformation as a primary checkpoint for nucleotide selection.

he remarkable fidelity of DNA synthesis is crucial for genome stability<sup>1</sup>. This fidelity depends on non-covalent transitions preceding the chemical step of phosphoryl transfer and serving as checkpoints whereby inappropriate substrates are rejected early during the reaction<sup>2</sup>. Among these transitions, the fingers-closing transition is of particular interest: the binding of the complementary dNTP to a polymerase-DNA (Pol-DNA) binary complex leads to a conformational change in which a part of the fingers subdomain (including the O-helix) moves from an open to a closed conformation (Fig. 1a-c), and forms a tight binding pocket around the nascent base pair<sup>3-6</sup>. Previously, we used single-molecule fluorescence resonance energy transfer (FRET) to examine fingers-closing in the Escherichia coli DNA polymerase I (Klenow fragment) (KF; see Santoso *et al.*<sup>7</sup>). Our results identified the open and closed conformations that predominate in the binary Pol-DNA and ternary Pol-DNA-dNTP (complementary) complexes, respectively, and showed that the unliganded polymerase explores both open and closed conformations<sup>7-10</sup>. We also showed that ternary complexes with non-complementary dNTPs or complementary ribonucleotides form distinct FRET species (with FRET signals intermediate between the open and closed states).

The fidelity and speed of DNA replication can be profoundly affected by substitution of amino acids near the polymerase active site<sup>11-14</sup>, implying that specific side chains control

the discrimination between correct and incorrect nucleotides. Two well-studied amino acids contributing to fidelity in KF are E710 and Y766 (Fig. 1a), both universally conserved within A-family polymerases<sup>15</sup>. Residue E710 helps in positioning the incoming nucleotide by interacting with the dNTP base-sugar portion, and acts as a steric gate that blocks incorporation of ribonucleotides<sup>16</sup>. Residue Y766 stacks on the template base of the terminal base pair and blocks the insertion site in the binary complex (Fig. 1b). Upon fingers-closing, Y766 rotates away from the terminal base pair and is replaced by the templating base, which moves into the catalytic pocket (Fig. 1c); the hydrogenbonded Y766-E710 pair creates part of the binding pocket and controls the nascent base-pair geometry.

Here, we report a conformational analysis of wild-type KF (wt KF) and KF derivatives with single amino-acid substitutions at E710 and Y766, respectively, and obtain conformational energy landscapes for various complexes along the prechemistry pathway. Three of the substitutions examined (E710A, Y766A and E710Q) decrease fidelity, acting as 'mutators'<sup>11–14</sup>; we also analysed Y766F, a derivative with enzymatic properties similar to wt KF<sup>11,14</sup>.

Since mutators fail to transition efficiently from the partially closed to the closed conformation, our results indicate that the partially closed state is an important fidelity checkpoint and that residues E710 and Y766 are essential for the discrimination between complementary and non-complementary nucleotides.

### Results

wt KF shows an on-pathway intermediate. The conformational profiles for wt KF alone and in complexes with non-extendable DNA substrates (Fig. 1d) are shown in Fig. 2a. The unliganded polymerase exhibits a broad FRET distribution (Fig. 2a, row 1), slightly biased towards an open conformation (60% occupancy,  $E^{*}_{\text{lowFRET}} \sim 0.48$ ). Formation of the KF–DNA binary complex (using DNA1, Fig. 1d) further increases the open-state occupancy (81%,  $E^{*}_{\text{open}} \sim 0.45$ ; Fig. 2a, row 2). The peak positions of the low-FRET species are slightly different in the unliganded polymerase and the binary complex; this is mainly because of unliganded polymerase dynamics<sup>7,8,10</sup>, but may also be due to conformational states other than the open and closed states, as discussed below.

Addition of the complementary nucleotide (A-dTTP) forms a ternary complex, wherein ~85% of all molecules display a closed conformation ( $E^*_{closed} \sim 0.66$ ; Fig. 2a, row 3). Notably, the presence of 1 mM dTTP (instead of 10  $\mu$ M used previously<sup>7</sup>) increases significantly the  $E^*$  of the low-FRET species ( $E^*_{lowFRET} \sim 0.51$ ) compared with the  $E^*_{open}$  in the binary complex (see Supplementary Fig. S1). Indeed, the  $E^*_{lowFRET}$  for 1 mM dTTP is closer to the intermediate-FRET species ( $E^* \sim 0.48$ ) also populated by complexes containing 1 mM of either non-complementary dNTP or complementary rNTP (A-dGTP and A-rUTP, respectively; Fig. 2a, rows 4 and 5). For both A-dGTP and A-rUTP ternary complexes, the occupancy ratio of the  $E^* \sim 0.48$  FRET species and the closed conformation is ~9:1.

We measured nucleotide-binding affinities by analysing FRET histograms generated at different nucleotide concentrations (Fig. 3a). The equilibria between the FRET species are depicted in Fig. 3c: the initial binding of a nucleotide (N) to the open binary complex (O) giving the intermediate-FRET species (IN) is described by the association constant  $K_1$  (or its reciprocal  $K_{d1}$ ), whereas the conformational equilibrium between (IN) and the closed ternary complex (CN) is described by constant  $K_2$ . In addition, the binary complex is in equilibrium between open (O) and closed (C) states, described by constant  $K_0$ . The nucleotide titrations provide two observables (Fig. 3a): the first is the peak shift of the low-FRET Gaussian (comprising the unresolvable O and IN species); the halfway point, corresponding to [O] = [IN], is at a nucleotide concentration equal to  $K_{d1}$ . The second observable is the fraction of polymerase complexes in high-FRET conformations. We used global fitting of both observables to obtain  $K_0$ ,  $K_1$  and  $K_2$  (Table 1). Extensions of our model are possible without altering its general conclusions; a five-state model including a potential intermediate-FRET species in the binary complex led only to a small additional scaling factor for *K*<sub>d1</sub> (see Supplementary Methods).

With wt KF, the complementary dNTP (A-dTTP) forms the intermediate-FRET species with a  $K_{d1}$  of 5.1  $\mu$ M (Table 1); the favourable equilibrium towards the closed complex ( $K_2 = 6.1$ ) augments the binding affinity so that the closed conformation is stabilized (dissociation constant of the closed ternary complex,  $K_{d2} = 1/(K_1K_2) = 0.83 \,\mu$ M). The affinity of incorrect nucleotides or complementary rNTPs for the intermediate state is weaker ( $K_{d1}$ : 46  $\mu$ M for A-dGTP, 210  $\mu$ M for A-rUTP and 30  $\mu$ M for A-rGTP; Table 1) and the low values of  $K_2$  (<0.2 in all cases) inhibit full fingers-closing.

Titrations of wt KF with nucleotides in the absence of DNA (Supplementary Fig. S2e) show formation of an intermediate-FRET species, as reported previously<sup>7</sup>. The initial binding affinity  $K_{d1}$  (3.0 µM for dGTP; 12 µM for rGTP) is similar to that for a

correctly paired A-dTTP ternary complex; however, the subsequent transition to the closed complex is not favoured ( $K_2 < 0.2$ , Table 1).

The conformations of wt KF with complementary and mispaired dNTPs at a template G and a template T (Fig. 4a) were similar to those for template A (Fig. 2a).

E710 has a critical role in the fingers-closing transition. The conformational profiles of unliganded E710A and its binary complex with DNA1 resemble those of wt KF (Fig. 2b, rows 1 and 2). However, addition of the complementary nucleotide (A-dTTP; Fig. 2b, row 3), even at high concentrations  $(\geq 1 \text{ mM})$ , led to only a modest increase in the occupancy of the closed state. Instead, the bulk of the population shifted from the open state ( $E^* \sim 0.44$ ) to an intermediate-FRET species  $(E^* \sim 0.48)$ . The  $K_{d1}$  for the E710A A-dTTP ternary complex was 43 µM (Table 1 and Fig. 3b), similar to that for wt KF with a mispair (A-dGTP), but several fold higher than that for wt KF with the complementary A-dTTP. Further, the  $K_2$  for the E710A A-dTTP ternary complex was <1, similar to mispairs with wt KF (Table 1), preventing efficient formation of the closed conformation. The interactions of E710A with both a non-complementary dNTP (A-dGTP) and a complementary rNTP (ArUTP) showed the same shift towards the  $E^* \sim 0.48$  state as with wt KF (Fig. 2b). With A as the templating base, E710A binds the incorrect dGTP 3-fold more tightly ( $K_{d1} = 16 \,\mu\text{M}$ ) than does wt KF ( $K_{d1} = 46 \,\mu$ M); interestingly, this incorrect interaction is also threefold tighter than the binding of the correct dNTP (A-dTTP) by E710A. For the complementary rNTP (A-rUTP), both  $K_{d1}$  and  $K_2$  are ~2-fold more favourable for E710A than for wt KF, probably owing to easier accommodation of the ribose 2'-OH when the glutamate side chain is replaced by alanine.

The behaviour of E710A at template G and template T (Fig. 4b) was as described for template A, except in the presence of complementary dNTPs. Despite weak initial binding of the complementary dNTPs, the more favourable  $K_2$  values of ~2 resulted in greater occupancy of the closed conformation (61% for G-dCTP and 58% for T-dATP at 1 mM dNTP); however, the overall affinity of E710A for all three complementary base pairs is low (Fig. 4d, Table 1), indicating that E710A discriminates poorly between correct and mispaired dNTPs regardless of templating base. The conformational profile for E710Q at template A (Fig. 2d) was similar to that of E710A (Table 1).

**Y766A perturbs fingers-closing for complementary dNTPs.** With template bases A and T, the Y766A mutator followed the pattern seen for E710A and E710Q (Figs 2d and 4c). Addition of complementary nucleotides (A-dTTP or T-dATP) led to equal occupancy of the intermediate-FRET and high-FRET states at high nucleotide concentrations ( $\geq 1$  mM). Addition of incorrect nucleotides (A-dGTP, G-dATP, or T-dGTP) formed predominantly the intermediate-FRET species. At template A and T, all dNTPs showed weak binding regardless of their complementarity to the templating base (Table 1).

However, at template G, Y766A bound the complementary dCTP as strongly as wt KF ( $K_{d1} = 1.0 \,\mu\text{M}$  for Y766A versus 1.2  $\mu$ M for wt KF, Fig. 4e) and formed the closed complex almost

exclusively, reflecting a very favourable  $K_2$  (Table 1). Moreover, the single-turnover kinetic parameters for G-dCTP incorporation by Y766A and wt KF (Supplementary Table S2) are similar, in contrast to those for A-dTTP incorporation. Thus, at template G, Y766A distinguishes well between correct and incorrect dNTPs.

The complexes of Y766F, which has similar fidelity to wt KF<sup>11,14</sup>, resembled those of wt KF (Fig. 2e, Table 1), the only difference being a ~3-fold decreased binding affinity ( $K_{d1}$ ) for the complementary nucleotide (A-dTTP) and an increased  $K_2$  (9.6) so that the overall  $K_{d2}$  is ~2-fold weaker for Y766F.

**Y766 modulates the equilibrium in unliganded polymerases.** Whereas the unliganded wt KF, E710A and E710Q polymerases exhibit similar conformational equilibria, Y766 substitutions shift the equilibrium (Fig. 2d,e). Loss of the bulky phenyl ring from the Y766 side chain increases the open-state occupancy to 78% (Y766A), whereas the more conservative Y766F substitution, which removes a potential hydrogen-bond donor, decreases the open-state occupancy to 28%.

The large differences between wt KF, Y766A and Y766F indicate that the interconversion rates between open and closed states depend on residue 766. To characterize the equilibria, we used probability distribution analysis (PDA)<sup>8,17,18</sup> and burst variance analysis (BVA)<sup>7,10</sup>, both described in Methods. PDA

revealed that the FRET distribution fits well either to a 'static' model of two independent molecular entities or a 'dynamic' model<sup>19,20</sup> that invokes dynamic interconversions of a single molecular entity between two distinct FRET states (Fig. 5a, top).

We used BVA to show that the dynamic model prediction fitted the data significantly better than the static model (Fig. 5a), suggesting the presence of dynamic heterogeneity for all three KF derivatives. To further analyse the conformational dynamics, we performed PDA using the FRET efficiencies  $E_i$  obtained from the initial PDA fit (dynamic model), and plotted the  $\chi^2$ -values as a function of  $k_1$  and  $k_{-1}$  (Fig. 5a, bottom). For wt KF, the minimization surface forms a distinct well at  $k_1 = 160 \text{ s}^{-1}$  and  $k_{-1} = 320 \text{ s}^{-1}$  ( $\chi^2 < 2$ ), consistent with our previous reports<sup>7,8,10</sup>. In contrast, both Y766A and Y766F display different landscapes (Figs. 5b,c), whereas Y766A shows a distinct well at  $k_1 = 15 \text{ s}^{-1}$ and  $k_{-1} = 120 \text{ s}^{-1}$ , Y766F displays a broad range of possible rate combinations with a shallow minimum at  $k_1 \sim 450 \text{ s}^{-1}$  and  $k_{-1} \sim 120 \text{ s}^{-1}$ .

Accessing the equilibrium dynamics of wt KF complexes. To characterize the timescales of interconversions within the sequential four-state model (Fig. 3c), we used PDA and a novel analysis of FRET distribution widths. Using PDA, we characterized the interconversions between O and C for the wt KF binary complex, and

between IN and CN for the wt KF ternary complex with an A-dGTP mispair at saturating nucleotide conditions (Supplementary Fig. S4); this analysis yielded rate constants of  $k_{O\rightarrow C} = 15 \text{ s}^{-1}$  and  $k_{C\rightarrow O} = 85 \text{ s}^{-1}$  for the binary complex and  $k_{IN\rightarrow CN} = 3 \text{ s}^{-1}$  and  $k_{C\rightarrow IN} = 45 \text{ s}^{-1}$  for the mispaired ternary complex.

Accessing the remaining rates (corresponding to rate constants  $k_{\Omega \to IN}$  and  $k_{IN \to \Omega}$  is challenging, as the analysis of the low-FRET species is hampered by our inability to resolve the FRET distributions of the O and IN states. Width analysis (see Methods) of our data (Supplementary Fig. S5c) revealed broadening of the low-FRET species around  $K_{d1}$  for several nucleotide titrations (for wt KF: A-dGTP and A-rUTP; for E710A: A-dTTP, A-dGTP and A-rUTP), indicating that the interconversions are at the millisecond timescale or slower. For the E710A A-rUTP titrations, for example, there is a maximum broadening of  $\sim 6\%$ at 100  $\mu$ M rUTP, close to the corresponding  $K_{d1}$  of 92  $\mu$ M. For a better estimate of the timescale, we simulated the four-state model using four fixed rates (by fixing  $k_{O \rightarrow C}$ ,  $k_{C \rightarrow O}$ ,  $k_{IN \rightarrow CN}$ and  $k_{\text{CN}\to\text{IN}}$ ) and varying  $k_{\text{O}\to\text{IN}}$  and  $k_{\text{IN}\to\text{O}}$  (Supplementary Fig. S5d; as in Santoso *et al.*<sup>7</sup>). The width of the low-FRET species at a nucleotide concentration equal to  $K_{d1}$  remains constant for high IN-to-O rates ( $\geq 300 \, \text{s}^{-1}$ ), whereas for rates of  $< 300 \, \text{s}^{-1}$ there is a significant width increase around K<sub>d1</sub>. We thus propose a rate of  $300 \,\mathrm{s}^{-1}$  as an upper limit for the IN-to-O transition.

### Discussion

Previously, we described a FRET state between the open and closed states for wt KF ternary complexes with incorrect nucleotides<sup>7</sup>. Data presented here strongly suggest that wt KF accesses this intermediate state even with complementary dNTPs, consistent with this state being on the path to nucleotide incorporation. Whereas the intermediate-FRET state is sparsely populated in the ternary complex of wt KF with a complementary dNTP, the three mutators (Y766A, E710A and E710Q) behave differently; their ternary complexes with complementary dNTPs occupy mainly the intermediate-FRET state, with Y766A and the G-dCTP base pair being the only exception.

Initially, we attempted to relate the intermediate-FRET species to available cocrystal structures, speculating that the ternary complex with a complementary rNTP undergoes partial fingers closure, whereas the mispaired ternary complex resembles a fingers-open conformation<sup>7</sup>. Since then, a better structural candidate for the intermediate-FRET species has been described<sup>21</sup>. Using *Bacillus stearothermophilus* DNA polymerase (a KF homologue), Wu and Beese<sup>21</sup> captured a partially closed ('ajar') fingers conformation (Fig. 6a) in a ternary complex with a G-dTTP mismatch, using both a mutator (Y714S, equivalent to Y766S in KF) and a non-mutator (F710Y, equivalent to F762Y in KF) polymerase; the partially closed state corresponds to fingersclosing along the open-to-closed transition, leading to a distance change of ~2 Å between the sites carrying the FRET probes, in excellent agreement with our observations.

Evidence for a partially closed state was also reported in a recent FRET study on immobilized KF complexes<sup>22</sup>. In contrast to our assay, which reports directly on conformational states by monitoring an intra-protein distance, Berezhna *et al.*<sup>22</sup> used donor-labelled DNA and acceptor-labelled polymerases to infer a protein conformational change by measuring a DNA-protein distance; in the latter assay, any protein conformational changes may be superimposed on concurrent DNA conformational changes, as well as on possible polymerase repositioning relative to the DNA.

The partially closed cocrystal structures may also relate to other intermediate-FRET species we have observed. By introducing a mutation that prevents full closing of the O-helix, Wu and Beese<sup>21</sup>

captured a partially closed *B. stearothermophilus* ternary complex with a correctly paired dNTP, a candidate for the sparsely populated species of intermediate-FRET value in the ternary complexes of wt KF with correct dNTPs. More speculatively, we note that the Pol-dNTP binary complex (without DNA) has a similar intermediate-FRET signature (Supplementary Fig. S2e; see also Santoso *et al.*<sup>7</sup>), suggesting that O-helix movement might be initiated by dNTP binding in the KF cleft without direct DNA involvement. Our  $K_d$  measurements (Table 1) indicate that nucleotide binding is destabilized by the presence of DNA with a non-complementary template base, just as DNA binding is destabilized by a mismatched dNTP (O.B., N.D.F.G., C.M.J, unpublished)<sup>23</sup>; both cases promote dissociation of mispaired ternary complexes.

It seems reasonable to assume that the partially closed complex is on the pathway to the chemical step, given that the partially closed state is structurally part way between open and closed states. We cannot directly rule out the alternative scenario whereby the partially closed conformation is an 'off-pathway' state in equilibrium with the open but not the closed state as, in either case, the equilibria follow similar relations (Supplementary Methods).

The partially closed conformation has the hallmarks of an early checkpoint, being populated in all wt KF ternary complex species, although these species progress differently along the reaction pathway. This conformation must be formed at an early step, most probably immediately after the Pol-DNA binary complex binds a nucleotide and its  $Mg^{2+}$  ion (step 2, Fig. 6b). Although our FRET pair does not distinguish between mispaired and rNTP-containing ternary complexes, experiments using 2-aminopurine on DNA substrates show that wt KF complexes with a complementary rNTP proceed further than mispairs (O.B., N.D.F.G., C.M.J, unpublished)23. A nanopore-based study of single KF-DNA complexes also supports this conclusion<sup>24</sup>. The partially closed conformation, therefore, encompasses at least two related ternary complexes (Fig. 6b) whose equilibria determine the progression of a particular ternary complex towards product formation. First, the partially closed ternary complex undergoes a base-checking step (step 2.1) in which the equilibrium is unfavourable for all non-complementary nucleotides (dNTPs and rNTPs), thus rejecting six out of the eight nucleoside triphosphates. Next, the sugar structure is tested against the active-site pocket (step 2.2), rejecting the bulkier rNTPs and allowing complexes containing complementary dNTPs to proceed to the closed conformation, from which they undergo subsequent steps, including D705 reorientation and binding of the second  $Mg^{2+}$  ion<sup>25</sup>.

The calculated equilibrium constants (Table 1) enabled us to propose a free-energy landscape for the prechemistry nucleotide selection steps (Fig. 6c). Although a simplified landscape has been proposed before (on the basis of fluorescence enhancement of a dye-labelled DNA upon T7 DNA polymerase binding<sup>26</sup>), our ability to monitor the conformational coordinate directly allowed us to add the important partially closed conformation checkpoint.

The dissociation constant for a nucleotide in the partially closed ternary complex,  $K_{d1}$ , reports on interactions in the wt KF active site. The binding of the complementary dNTP is favoured, leading to a stabilized partially closed state ( $-8 \text{ kJ} \text{ mol}^{-1}$  for A-dTTP versus  $-0.7 \text{ kJ} \text{ mol}^{-1}$  for A-dGTP, using the nucleotide concentrations in *E. coli*<sup>27</sup>); this may result from tighter binding within either or both of  $E_{PC} \bullet DNA \bullet r/dNTP \cdot Mg^{2+}$  and  $E_{PC} \bullet DNA^{\bullet} r/dNTP \cdot Mg^{2+}$  (see Fig. 6b). Moreover, the similar  $K_{d1}$  values for A-dGTP and A-rGTP complexes (Table 1) indicate that the ribose 2'-OH is not detected in the initial  $E_{PC} \bullet DNA \bullet r/dNTP \cdot Mg^{2+}$  complex.

 $K_2$ , describing the equilibrium between partially closed and closed complexes, defines the free energy of the closed ternary complex. When  $K_2$  is >1, as for correctly paired ternary complexes of wt KF, the closed complex is the lowest-energy species ( $-4 \text{ kJ mol}^{-1}$  relative to the A-dTTP partially closed state) on the prechemistry pathway, and its enhanced stability relative to the partially closed ternary complex ( $K_{d2} < K_{d1}$ ) drives the forward reaction. With an inappropriate substrate, such as a mispair,  $K_2$  is <1 so that the closed complex is destabilized relative to the partially closed ternary complex ( $+6 \text{ kJ mol}^{-1}$  for A-dGTP) and the equilibrium favours species formed early in the pathway. The extremely slow rates for misinsertion ( $\geq 10^3$ -fold slower than complementary dNTP additions) probably result from low occupancy of the closed conformation combined with active-site distortions<sup>13,14</sup>.

The fidelity mutants in this study show a reduced ability to recognize complementary dNTPs as 'correct' (Table 1), having lower affinity for the initial binding of the complementary dNTP to the partially closed complex and an unfavourable  $K_2$ . Therefore, the partially closed conformation is highly populated in the resulting ternary complexes so that, in the absence of the E710 or Y766 side chains, the complex with the complementary dNTP resembles a mispaired complex. Our data show a continuum of behaviours, with both the templating base and the particular mutator allele influencing how far the conformational equilibria shift towards the closed state; at one extreme is the E710A A-dTTP complex, which has little of the closed conformation ( $K_2 = 0.25$ ), at the other is the Y766A G-dCTP complex, which resembles wt KF ( $K_2 = 8.9$ ); in between are several complexes with  $K_2 \sim 1$ , having substantial amounts of both closed and partially closed complexes.

Why should alteration of E710 or Y766 destabilize the closed ternary complex? Structurally, E710 and Y766 define much of the surface of the active site-binding pocket so that they interact more closely with the nascent base pair in the closed complex than in the partially closed complex, where the base pair is more solvent exposed. Surprisingly, the hydrogen bond between E710 and Y766, despite being invariant in A-family DNA polymerases, has a minor role in the closed complex stability, as shown by the similar FRET profile for complexes of Y766F and wt KF. More important may be the overall size and shape of the 766 side chain and its ability to interact with and position the nearby F762 side chain, which forms part of the binding pocket.

Structural studies argue that the transition from partially closed to fully closed conformation is required for catalysis of the polymerase reaction. In the partially closed conformation, the primer 3'-OH is too far from the  $\alpha$ -phosphate of the bound nucleotide; moreover, the rest of the active site, including the catalytic metal ions, is not properly assembled for a chemical attack<sup>21</sup>. Our data support this reasoning, showing a rough correlation between the rate of nucleotide incorporation  $(k_{pol}, Supplementary Table S2)$  and closed-complex occupancy; the most notable example is G-dCTP incorporation by Y766A, where high occupancy of the closed complex correlates with near-wild-type kinetics. Moreover, for the mutator proteins, the single-turnover  $K_d$  for A-dTTP incorporation ( $K_{d(dNTP)}$ , Supplementary Table S2) approximates to  $K_{d2}$  (Table 1), consistent with closed-complex formation being required for the chemical step. (This assumes that the chemical step is rate limiting for these mutant proteins. For wt KF (and probably Y766F), the same relationship does not hold, as prechemistry step 3 is rate limiting)<sup>28</sup>. Nevertheless, as the low incorporation rate for E710Q shows (Supplementary Table S2), achieving the closed state with moderate efficiency is, of itself, no guarantee of effective catalysis if the mutation distorts the final active-site geometry.

Our data support the generalization that alterations in polymerase fidelity correlate with the kinetics of handling correct, rather than incorrect, nucleotides<sup>29</sup>. Compared with wt KF, the mutator variants show at most a threefold enhancement in the binding ( $K_{d1}$ ) of the non-complementary A-dGTP and no improvement in  $K_2$ . This contrasts with the much larger deficits in both constants for the mutators when binding the correct A-dTTP. As the closed complex selects for the correct template-dNTP pairing, any change to the energetics of this complex will exclusively affect correct dNTP incorporation. Moreover, even in the partially closed conformation, changes in active-site side chains diminish specificity for the correct pairing more than they enhance the interaction with mispairs.

The effects of template base and mutator allele on closedcomplex energetics provide a partial explanation of the observed error specificities of the KF mutators (Supplementary Fig. S6)<sup>11-14</sup>. Closed complexes with the correct dNTP are least populated when E710A encounters template A or when Y766A encounters template A or T, making these the situations where recognition of the correct base pair is least effective. One would therefore expect E710A to be less accurate at template A than that at G or T, and Y766A to be less accurate at templates A and T, relative to G. This is consistent with the high frequency of A-dCTP errors made by E710A and T-dGTP made by Y766A but does not explain the lower frequency of other errors at these particular template bases. The substantial frequency of Y766A G-dTTP errors is noteworthy, given that Y766A handles the G-dCTP pair with almost wild-type efficiency; this could be a case where a mutator actually facilitates the interaction with the mispair, consistent with earlier kinetic data<sup>14</sup>. As the experimentally observed polymerase errors in

Supplementary Fig. S6 require not only covalent addition of mispaired bases but also extension of the resulting mismatched primer termini, they will be influenced by steric or geometric constraints in intermediates for both reactions so that the overall error specificity reflects the combination of several factors.

Finally, our results on the unliganded Y766 polymerase derivatives reinforce our previous observations that the conformational equilibrium of the unliganded polymerase is delicate; thus, the removal of even a single oxygen atom (as in Y766F) increased substantially the occupancy of the closed state for the unliganded polymerase, whereas the more drastic Y766A mutation had the opposite effect. By contrast, changes to the 710 side chain did not influence the conformational equilibrium, suggesting that the behaviour of Y766 derivatives is not directly related to the missing 710-766 hydrogen bond in the closed conformation. An alternative explanation considers, instead, the open conformation, where the 766 side chain is extremely solvent exposed; one might expect the side chains to favour the open conformation in the reverse order of their hydrophobicity: A > Y > F, as is observed. Unlike the unliganded polymerase, the FRET distributions of binary complexes of the mutant and wt polymerases were similar, indicating that the conformational landscape is dominated by Pol-DNA interactions, and that the apparent conformational equilibrium of unliganded polymerases is not a reliable predictor of the conformational landscape of the corresponding binary complexes.

### Methods

**Single-molecule FRET measurements.** Single-molecule FRET experiments were performed at room temperature ( $\approx 22$  °C) using a home-built confocal microscope equipped with 20 kHz alternating laser excitation between a 532-nm (operated at 240 µW) and a 638-nm laser (operated at 60 µW), coupled to a × 60, 1.35 NA, UPLSAPO 60XO (Olympus) objective. The alternating laser excitation allows filtering for correctly labelled species bearing an active donor and an active acceptor<sup>30</sup>. After filtering each fluorescent burst for the correct labelling stoichiometry, we calculated the apparent FRET efficiency *E*\* for each burst as *E*\*= DA/(DD + DA), where DA is the number of photons in the red detection channel after green excitation. Doubly labelled KF derivatives were present at <100 pM in single-molecule observation buffer (40 mM 4-(2-hydroxyethyl)-1-piperazineethanesulfonic acid (HEPES)-NaOH, pH 7.3, 10 mM MgCl<sub>2</sub>, 1 mM dithiothreitol, 100 µg ml<sup>-1</sup> bovine serum albumin, 5% (vol/vol) glycerol, 1 mM

**Analysis of FRET histograms.** Single-molecule FRET experiments are sensitive to subtle changes in conditions such as room temperature and set-up alignment<sup>30,31</sup>. To minimize changes, every set of experiments contains reference measurements of a DNA FRET standard with a reference FRET value of  $E^* \sim 0.5$  (ref. 32), the unliganded polymerase, the binary complex formed with DNA and the ternary complex with DNA and nucleotides. Each titration experiment was completed in a single day.

The stoichiometry-filtered  $E^*$  FRET histograms were fitted to double-Gaussian functions that were constrained by a maximum width of  $\sigma_{max}$  ( $E^*$ )  $\leq$  0.07. The double Gaussians report on peak positions and relative occupancies. For titration experiments, we plotted the relative peak shift ( $E^*_{obs} - E^*_{open}$ )/( $E^*_{closed} - E^*_{open}$ ) of the low-FRET Gaussian and the fractional occupancy of the high-FRET Gaussian as a function of nucleotide concentration. We fixed the position of the high-FRET Gaussian to the value obtained from a free fit of the binary complex or a saturated ternary complex with complementary dNTPs. We did not fix the position of the low-FRET Gaussian.

**Derivation of the multistate equilibrium model**. To determine the parameters governing the equilibria between the species observed in the single-molecule FRET histograms (Fig. 3c), we derived equations for the two concentration-dependent FRET observables: the peak position of the low-FRET Gaussian and the fraction of the population in the high-FRET Gaussian. The binary complex is in dynamic equilibrium between open (O, low-FRET) and closed (C, high-FRET) conformations, described by the equilibrium constant  $K_0 = [C]/[O]$ . Binding of a nucleotide (N) to the open conformation, forming the intermediate-FRET ternary complex (IN), is described by the association constant  $K_1 = [IN]/[O][N]$ . The intermediate-FRET ternary complex can undergo an additional conformational

transition to the closed ternary complex (CN, high-FRET), governed by the equilibrium constant  $K_2 = [\text{CN}]/[\text{IN}]$ . The corresponding dissociation constants are defined as  $K_{d1} = 1/K_1$  for the formation of the intermediate-FRET state and  $K_{d2} = 1/(K_1K_2)$  for the formation of the high-FRET (fully closed) state. The total polymerase concentration is

We used a global fitting approach to fit both FRET observables simultaneously as a function of nucleotide concentration, and to determine the equilibrium constants  $K_0$ .  $K_1$  and  $K_2$ , and the parameter  $y_{\rm max}$ . From the equilibrium constants and their s.e., we calculated the dissociation constants. Identical equations can be derived to describe nucleotide binding to the polymerase in the absence of DNA; in this case, O and C refer to the unliganded protein.

**Probability distribution analysis and burst variance analysis.** For PDA<sup>8</sup>, the static model is fully described by two peak positions  $E^*_{i}$ , two excess widths  $\sigma_i$  (accounting for additional broadening of  $\langle E^*_i \rangle$  due to acceptor

photophysics<sup>17,19</sup>) and two relative occupancies  $N_i$ . In comparison, the dynamic model replaces the relative occupancies with two rate constants:  $k_1$  for the open-toclosed transition and  $k_{-1}$  for the closed-to-open transition. We optimized parameters for both models using a least mean square algorithm implemented in MATLAB. BVA directly evaluates FRET distributions for the presence of dynamic heterogeneity<sup>10</sup>. In BVA, the experimentally measured s.d. of the FRET efficiency for individual transits through the confocal spot is compared with the s.d. predicted by the static and dynamic models.

Width analysis for obtaining rate constants. At nucleotide concentrations equal to the dissociation constant  $K_{d1}$  (where [O] equals [IN]), the interconversion rates between O and IN,  $k_{O \rightarrow IN}$  and  $k_{IN \rightarrow O}$ , are equal. These rates also control the width of the low-FRET species distribution: if  $k_{O \rightarrow IN}$  and  $k_{IN \rightarrow O}$  are high and lead to multiple interconversions during the transit of the complex through the detection volume (~3 ms (ref. 7)), the FRET averaging between O and IN will yield a FRET width for the low-FRET species that matches that for the binary or partially closed ternary complex for all nucleotide concentrations. In contrast, slower interconversions will lead to a FRET-width increase; this increase should peak around  $K_{d1}$  (Supplementary Fig. S5a,b).

Calculating the free-energy landscape of ternary complexes. To construct the free-energy landscape for the prechemistry conformations of wild-type DNA polymerase in the presence of nucleotides, we calculated the relative Gibbs free energies  $\Delta_r G$  for the partially closed conformation and the fully closed conformation in ternary complexes by using the open conformation in the binary complex as a reference. To estimate  $\Delta_r G_{(O/IN)}$ , the free-energy difference between the open conformation and the partially closed conformation, for a complementary dNTP (A-dTTP), we used:  $\Delta_r G = \Delta_r G^0 + RT \ln(Q_r)$ . The first term,  $\Delta_r G^0$ , is the free energy corresponding an O-to-IN equilibrium with 1 M concentrations for all species involved and is calculated using  $\Delta_r G^0 = -RT \ln(K_1)$ , where R is the ideal gas constant, T the temperature and  $K_1$  is the equilibrium association constant measured using our nucleotide titration experiments (Table 1). The second term requires the reaction quotient Qr, which is a function of the actual concentrations of all species involved in the equilibrium:  $Q_r = \{[IN]/[O][N]\}$ . To estimate  $Q_r$ , we set [N] to the E.coli intracellular concentration for dTTP  $(120\,\mu M)^{27}$ , and assumed that [IN] = [O]. To estimate  $\Delta_r G_{(IN/CN)}$ , the free-energy difference between the partially closed conformation and the closed conformation with bound nucleotide, we used  $\Delta_r G_{(IN/CN)} = -RT \ln(K_2)$ . Similar expressions were used for the free (A-dGTP); for dGTP, we used  $[N] = 60 \,\mu M^{27}$ . Using the proposed rate of  $\sim 300 \,\mathrm{s}^{-1}$  as an upper limit for the rate of the IN-to-O transition for A-dGTP, we calculate the rate of the O-to-IN transition at 60  $\mu$ M dGTP in *E.coli* as follows: rate =  $K_1 \bullet k_{IN \to O} \bullet 60 \ \mu$ M = 21.7e10<sup>3</sup> M<sup>-1</sup>  $\bullet$  300 s<sup>-1</sup>  $\bullet$  60 $\bullet$ 10<sup>-6</sup> M = 390 s<sup>-1</sup>

The following procedures are further described in the Supplementary Methods: DNA preparation, protein expression and purification, and site-specific labelling of KF.
