As of 31st July 2014, 621 research outputs have been identified that are RCUK funded, with one or more Leeds author and published between 1st April 2013 and 31st July 2014. Publications were identified from the following data sources

- Web of Science
- Scopus
- University of Leeds Publications Database
- RoS
- Applications for RCUK block grant to pay for APCs

The figures in the table provide a snapshot of compliance at 31st July 2014. It is likely that the information about the number of Leeds publications is incomplete and underestimates the University's Research Council funded output. Over time, the compliance rate is likely to rise as more papers are added to open access repositories by authors or publishers. All the outputs identified are either journal articles or conference proceedings.

Of the 323 gold papers, in 166 instances APCs were paid for by the University of Leeds. The other 157 were either paid for by other institutions, or it is possible that no APCs were paid. Twenty four of the 31 partially compliant gold papers are MRC or ESRC funded and could be compliant if they were added to the appropriate subject or funder repository by the funder deadline. We have not yet finished analysing the embargo periods for the 203 non-compliant or partially compliant green papers but early indications are that most of these could become compliant if they are added to the institutional repository, PubMed Central or the ESRC catalogue as required by RCUK. Twenty papers have been identified so far that exceed the MRC embargo period of six months. Information about embargo periods was obtained from SherpaFACT and relates to the longer embargo periods permitted by RCUK during the transitional period to 2017.
